Call to Order

If an issue arises that she must be present, council will have a special meeting to address that issue. Gray motioned to have Crist represent the town under the conditions. Mullins seconded the motion. Motion carried 4-0.

Welcome Visitors

- Kathy Finney was present to ask about her yard. It was disturbed during the water project and it has not been restored to previous conditions. It was determined by discussion that it was Cobalt. Clark informed her that they would contact Cobalt.
- Ginny Cox was also present to ask about her yard from Cobalt. They were also supposed to replace a fence, which has not happened yet. Her name will be added to the list for Cobalt.
- Pam Bicknell was present to discuss some issue concerning speeding and things coming up
 missing from people's properties. In addition, she asked about a curfew. There is a curfew for the
 anyone under 18 years of age unless accompanied with relative. She is interested in forming
 some type of community watch group.
- Paul Parker was present to express some concerns, which were the same as the previous visitors.
 He asked whether anyone checked with the funeral homes about funerals scheduled during the
 park paving. He inquired about a link to ordinances. McGuire and Marshal Martin informed him
 that it is being worked on and that some common ones are on the website already.

Any changes in law that affects policies will be updated automatically. Applying through Bliss McKnight, the town's liability insurance provider, provided a 10% discount and they are willing to pay 10% of the cost. This makes the total cost \$1,649.16. He would like to use ARPA funds for this purchase. McGuire informed council that the funds are there now but may not be there in the future. Marshal Martin agreed to cancel if funds are not available in the future. Gray motioned to approve Lexipol for the first year using ARPA funds. Hayes seconded the motion. Motion carried 4-0.
